GUIDE FOR THE SUBMISSION OF APPLICATIONS IN THE PROCESS OF PRE-REGISTRATION FOR DOCTORATE AT THE UNIVERSITY OF MÁLAGA

The University of Malaga prepares this guide in order to advise applicants for Doctoral studies on the use of the DUA platform for applying for admission to Doctoral Programs that our university offers.

The application for admission submitted will, in the first instance, be reviewed by the Doctoral Service, which will verify that the candidate meets the requirements for access to doctoral studies established in Royal Decree 99/2011, of January 28, which regulates official doctoral studies. Subsequently, the Academic Commissions will assess the merits of the admission applications in two phases (provisional assessment and final award), within the periods determined by the pre-registration calendar published at the University of Malaga.

The steps to follow to access the platform and to be able to correctly complete the application for admission are detailed below.

Clicking "Continue" displays a message to disable the pop-up inhibitor if it is enabled.





For security reasons, the platform will automatically log you out in a short period of time. However, you can save your application and access it with your access password that will be provided to you at the end of the process, during the period for submitting applications to modify it, add or delete documents provided, etc.

Each time you access and modify your request, a new password will be created that will be the only one valid for the next access.

Pay attention to fill in the data correctly, especially the email address and mobile phone number (they will also be requested at the end of the process for notifications)

In addition, in your email you will receive the access password and the receipt of having submitted the application.

This is the time to record whether the applicant has been awarded a scholarship (only applicable in the phase for scholarship holders), or if the applicant has a recognized disability with a degree of 33% or higher.

You must check the box and attach the supporting documentation by clicking on "Manage documentation".

Currently, 5% of the total number of doctorate places offered are reserved for students who can prove a degree of disability equal to or greater than 33%.

In the case of being admitted to a Doctoral Program, you must provide the originals and photocopies of the documentation provided during the pre-registration process at the Secretariat of the Center responsible for the respective Doctoral Program within a month after formalizing the registration according to the instructions in the Guide for the registration of students of Doctoral studies.

In those cases in which the documentation has not been issued in Spanish, it must be accompanied by the corresponding official sworn translation.

Once you have filled in the personal data, click on "Next" in the upper right corner, where the screen appears to choose the access path.

On every screen, this image will appear which will help you at the moment.

Once the fields are filled in, the applicant must attach the requested documentation by clicking on "manage documentation". A pop-up window will open where you can attach all the requested documents.

Click on "Browse..." to be able to select the documents to be attached. When selected, click on "Attach file" so that the document is uploaded to the platform. When there are no more documents to attach, you can click on "close this window" located in the upper left corner.

Before closing the window, note that the uploaded documents are listed in a list on the left side of the window, under "Contributed documents"

If for any reason the applicant wishes to cancel this path, they will have to click on the "Cancel" button, located below the fields to be filled in the path. Otherwise, once the fields have been filled in and the relevant documents have been uploaded, click on "Finish this access path" so that the chosen access path is saved in the system.

- Official academic certification corresponding to the alleged title (in the certification the final average grade of the file, the minimum passing grade and the maximum obtainable grade must appear, as well as the year of beginning, year of completion and total duration in years).
- Document issued by the authority of the foreign country that accredits access to doctoral studies (model equal or similar mandatory contribution to participate in this way).

Once this step is completed, the next one can be accessed in the same way as before, by clicking on "next", to reach the "Requests" screen.

Once the personal data and access routes have been completed, the next step is to choose the Doctorate Program to which you wish to access. A list of the different Doctoral Programs offered by the University of Malaga will be displayed.

If you do not find the Doctoral Program, you can do a search.

To access the application form for the Doctorate Program, click on the name of the Doctorate you want to access. Once the Doctorate has been selected, the following window will appear so that you can fill in the information requested.

The sections that each Doctorate Program has established will appear, indicating the percentage in the scale applied. If in any section, such as here in "Academic record" it indicates that "Documentation is not required" it is because it was already provided in the "Access routes" step.

To attach documentation in the other sections other than the academic record, you must download the form and the files by clicking on "download model to fill in here".

Fill in the form and documents, save them on your PC and attach them by clicking on **"Manage documentation"** - **"Browse"** - **"Attach file"**. You must attach all supporting documents of the merits consigned in the forms, in PDF format and with a maximum size of 4 MB each.

There is a generic form for most Doctoral Programs and other specific ones:

Letter of support for the Doctoral Program in Psychology. You must download it and send it to the professor who endorses the direction or tutoring of the thesis, following the instructions.

Doctoral Program in Advanced Biotechnology, model letter of endorsement:

This procedure is the same as in the previous step. Once the documents have been provided, they will appear as "Documents provided"

Important: "In order for the merits consigned in the forms to be taken into account in the assessment of your application, you must attach the files corresponding to everything specified in your curriculum, concerning courses, seminars, conferences, congresses, etc. (attaching supporting documents by clicking on "manage documentation")

In the second field to fill in, reference is made to the level of dedication that will be given to the doctorate, choosing full time or part time.

5. Recording and sending of the request

Once the applicant has completed all the required information, the next step will take them to validate and save the application. You must fill in the "mobile phone" and "e-mail" fields with the same data as on the first screen when you began to fill in the application with your personal data.

The request will be recorded and sent to the University of Malaga. The applicant will receive an application notification sent by email and by SMS to the mobile. In the email you will also find attached a document as a receipt of the application ("the PDF of the application")

Once the process is finished, the applicant will be able to "view the PDF of the application", "close the session", "modify the application" or "cancel application"

During the application submission period, the applicant may also access their application using the last access password that was sent to them. If you modify something (adding or deleting petitions, documentation, etc.) another access password will be generated and the last one received will always be the valid one in order to access your request.

6. Provisional assessment of merits and award of results

On the dates established in the pre-registration calendar, the applicant will receive a notification to their email address with the **PROVISIONAL ASSESSMENT OF MERITS** and they will be able to consult their application in the Access link to the merit assessment consultation.

At that time, a period will be opened to make allegations to the provisional scales. To do this, you must access the Management platform for allegations, notifications and claims enabled for this purpose. The platform will be accessed through the NIF or equivalent document number provided and the password that was provided when generating the request.

Within the same period, you must provide the documentation that may be required by the Academic Committee of the Program.

7. Candidate selection

At the end of the period for the presentation of allegations, the award of the places offered will be notified to the email address and the applicant will be able to check their status on the same platform of Common Access to the consultation of the evaluation of merits or of the Adjudication of plazas.

The status of the request may be:

- Admitted. Compulsory enrollment (in this case, you must do it online within the estimated period and through of the self-registration link received by email)
- Excluded (includes the causes of exclusion)
- Waiting list (and the position you are in on the waiting list)

Only in the event that some of the admitted students do not formalize enrollment during their enrollment period, the waiting lists will begin to be managed, informing the applicants, in the order established in the evaluation of merits, that they have been awarded a place and that if they wish they can formalize the enrollment within the period granted to them.

If an applicant on the waiting list is not contacted, it means that there have been no vacancies until their place on the list is reached and if they wish to access Doctorate studies in the future, they must go through the preregistration process again.

After the completion of the presentation of applications and at all times, applicants will receive by email the steps they must follow and the links to which they must access for consultation in accordance with the dates published in the Doctorate Pre-registration calendar in the Malaga University.
