KISS Deemed to be University: Kalinga Institute of Social Sciences (KISS) was founded by Prof. Achyuta Samanta in the year 1992 with a view to imparting quality education to the poor tribal children from standard I level to post graduation as well as Doctoral level research absolutely at free of cost in residential set up. It was given higher Deemed to be University status by the Ministry of Human Resource Development (HRD), Government of India in August, 2017 U/S 3 of UGC Act 1956. This University is the first Tribal University in the entire world and is dedicated to work exclusively for educating and empowering tribal students. The University has introduced seven new innovative courses in the first phase to provide impetus to research in the areas of tribal economy, indigenous knowledge systems, religion, heritage and culture, tribal indology, languages and literature. Besides implementing the United Nation's Sustainable Development Goals in its true sense, KISS has been able to bring about much needed social changes in the fields of inclusive education, women empowerment, tribal upliftment and sustainable development in tribal areas of Odisha and its neighbouring states.

- APA (American Psychological Association) reference style should be followed.
- Selected Articles will be published as Conference Proceedings having ISBN number.

Format for Writing Full Paper

Title page

- Title Concise and informative.
- Author names and affiliations Authors' affiliation addresses (where the actual work was done) below the names. Indicate all affiliations with a lower-case superscript letter immediately after the author's name and in front of the appropriate address. Provide the e-mail address and contact number of each author.
- **Corresponding author** Clearly indicate the name and postal address of the corresponding author with telephone and fax numbers (with country and area code) e-mail address who will handle correspondences at all stages of refereeing, publication and post-publication.

Article Structure

Abstract

A concise and factual abstract stating the purpose, method adopted, principal results and major conclusions is desired. The length should be less than 250 words.

Keywords

Maximum 5 key words to be given following the abstract

Body Part

The body of the article/paper should contain Introduction, Literature Review, Methodology, Results, Discussions, Suggestions and Conclusion followed by References.

Appendices, tables, formulae, figures etc. need to be given with suitable numbers and titles
