

RESOLUTION OF NOVEMBER 22, 2024, FROM THE INTERNATIONAL RELATIONS OFFICE OF THE UNIVERSITY OF MALAGA, REGARDING THE PUBLICATION OF THE PROVISIONAL LIST OF EXCLUDED CANDIDATES FOR THE SELECTION PROCESS OF INTERNATIONAL STAFF MOBILITY (TRAINING AND TEACHING) IN THE ACADEMIC YEAR 2024-2025, WITHIN THE FRAMEWORK OF THE ERASMUS+ KA171 PROJECT 2022.

In accordance with the provisions of the resolution dated April 25th, 2024, published by the International Relations Office of the University of Malaga, which sets out the regulations governing the selection process in partner institutions for undergraduate and graduate students and staff, within the framework of the Erasmus+ KA171 programme, the provisional list of excluded applicants, along with the reasons for exclusion, has been published.

Additionally, pursuant to the aforementioned resolution of April 25th, 2024, published by the International Relations Office of the University of Malaga, partner institutions are hereby informed that they may submit objections via email to icm@uma.es, addressed to the International Relations Service. Such objections must be accompanied by the requested documents and justifications within 5 calendar days from the day following the publication of these lists.

Upon the conclusion of the objection period, the final list of admitted and excluded staff will be published, along with the allocation of places. Admitted staff members may then proceed with registration and subsequent procedures for their mobility at the University of Malaga. It is important to note that final acceptance and issuance of the acceptance letter for visa purposes will be subject to the fulfilment of administrative procedures.
