The Latin American Association of Aeronautical and Space Law – ALADA and the University of Málaga are jointly organizing the 38th Latin American Meeting on Aeronautical and Space Law (International Conference) and invite scientific contributions investigating on the following topics:

CONFERENCE TOPICS

Contributed papers should be focused on one of the conference panels:

PANEL 1: Competition and collaboration between airport infrastructures.

PANEL 2: Air transport and tourism.

PANEL 3: Drones.

PANEL 4: Airline companies, commercial strategy and competition.

PANEL 5: Commercial exploitation of outer space and the Moon.

SUBMISSION GUIDELINES

Participants should initially submit an extended abstract (2 to 5 pages) and depending on the outcome of the review process, they will be invited to submit full papers. The Scientific Committee will review all the abstracts, and authors of accepted abstracts will be invited to submit full papers through the e-mail address below. In addition, some of them will be selected for oral presentation.

PUBLICATIONS

All accepted papers will be published in the conference proceedings (full papers in electronic format with ISBN).

A selection of papers from the conference will be considered for the 14th issue of *Revista de Derecho del Transporte* (Marcial Pons), to be published in October 2014.





MANUSCRIPT GUIDELINES

- 1. Manuscripts submitted should be original contributions and should not have been previously published nor under consideration for publication elsewhere. Individual and multiple authors are welcome to contribute.
- 2. All manuscripts should be typed in MSWORD format.
- 3. Manuscripts must be written in English, Spanish or Italian.
- 4. Manuscripts should not exceed 20 pages (including bibliographical references), with a minimum of 15 pages.
- 5. First page should include the following information: title, author, academic or professional affiliation of the author, conference panel to be included, postal address, telephone number and e-mail.
- 6. Main body of the text should be preceded by an abstract, keywords and a summary, and must follow these specifications:
- Text: single-spaced Times New Roman, font size 12.
- Title: Bold, uppercase, font size font size 12.
- Main headings (numbered): Bold, uppercase, font size 12.
- Sub headings (numbered): Bold, lowercase, font size 12.

Examples:

1. Sub-heading

Lower level lists should use letters: a) b) c) etc.

- 7. Bibliographic references in footnotes should include author's name, year of publication and pages.
- 8. The format for the final bibliographic reference list should be as follows:
- MÁRQUEZ LOBILLO, P. (2013): Denegación de embarque en el transporte aéreo de pasajeros. Madrid
- TULLIO, L. (2013): "L'obbligazione di protezione nel trasporto marittimo e aereo
- The duty of care in maritime and air transport,". *Rivista Diritto dei Trasporti*, n. 2, pp. 349-368.

References to webpages will be added at the end of the reference list.
