



**MOBILITY CALL DATED 14TH JUNE 2023 FOR STUDENTS (UNDERGRADUATE, PhD, Master) AND STAFF (TRAINING AND TEACHING) STAYS AT THE UNIVERSITY OF MALAGA, WITHIN THE FRAMEWORK OF THE EUROPEAN PROGRAMME ERASMUS+ KA171**

### **I. PURPOSE OF THE CALL**

The present Call is based on the funding awarded to University of Malaga (UMA) for mobility projects with EU-partner countries under Key Action 171 of the Erasmus+ Programme for Undergraduate, Master, PhD students and staff members.

The purpose of this call for applications is to establish the basis for the selection process in the partner institutions for undergraduate and postgraduate students and staff members who, meeting the requirements, wish to participate in mobility stays at Bachelor, Master or Doctoral level (students) and teaching and training stays (staff members) at University of Malaga within the framework of Erasmus+ KA 171 International Dimension mobility program, subject to the acceptance of the candidate by University of Malaga and in accordance with the provisions of the agreements signed between the aforementioned institutions and the University of Malaga and according with the nomination process established in this call

There may be changes in the number of places, depending on the transfer of places available and vacancies in other countries of the same region, types of mobilities and flows and the funding awarded every year for Erasmus+ KA171.

Every academic year, University of Malaga will publish the number of places available, study cycle, subject area, type of mobilities together with the specific conditions (application process, timeline and grant payment procedure). for the projects in progress.

All partner institutions will publish every year their own call with their specific selection process for students and staff.

Mobilities announced in this call should be carried out along the Erasmus+ KA 171 validity period.

In the event that, for the same country of origin, there are grants from previous calls (projects) not being awarded, the grants for the projects with the closest deadline will be awarded first.

### **II. PLACES AND PARTNER INSTITUTIONS**

#### **Interinstitutional Agreements**

An Interinstitutional Agreement between the home and the host universities must be signed before the start of the mobility.

Places available every year can be found in the corresponding Annex of the project and year, distributed by country, partner institution, thematic fields and type of mobility in this [link](#)

### **III. GENERAL CONDITIONS**

#### **a) Period of Stay**

The **duration of the stay for students** will be a maximum of five months. Exceptional circumstances will make possible a shorter or longer period but duly justified and authorized by this Vice-Rectorate for Mobility and International Cooperation. Otherwise, the candidate will have to return the entire grants.





During their stay PhD students should engage in research towards their doctoral thesis.

**The mobility period for staff member** is 5 days with 2 days for travel, covering 7 days in total.

Staff mobility can be for teaching, training, or both.

- During mobility for teaching (STA), staff should deliver at least 8 teaching hours per week.
- During mobility for training (STT), staff should receive training, engaging in professional development activities such as training events (excluding conferences), job shadowing, or observation periods at the receiving institution.
- Mobility can also be for teaching and training. In this case, the minimum number of hours of teaching is 4 hours per week.

#### b) Finance

The mobility grant for students consists in a travel allowance and a monthly subsistence allowance according to the flat rates determined by the Erasmus+ KA 171 Programme.

The mobility grant for staff consists in a travel allowance and seven days payment according to the flat rates determined by the Erasmus+ Programme

The grant should be regarded as a contribution towards the costs of mobility rather than covering 100% of the involved costs.

Selected participants will need to advance their own funds when organizing their stay, such as visa, insurance, flights and accommodation, since the mobility grant will be paid only once their stay begins.

It is highly advisable to make bookings (flights, accommodation etc.) on conditions that allow reimbursement in case of cancellation of travel.

The aids for mobility grants within the framework of this Call comes from funds of the European Commission, which are managed by the Spanish Service for the Internationalization of Education (SEPIE).

#### The financial aid includes:

- Individual support for students. The amount is 850 € per month of activity and if applicable for fewer opportunities an additional amount of 250 €/month
- Individual support for staff. The amount is established according to the country of origin and the actual number of days of stay at University of Malaga. In Spain the amount is 160 euros per day. The eligible period is 5 days of stay + 2 days of travel (1 day departure and 1 day return). In total, 7 eligible days, for an amount of 1,120 euros.
- Additional support for travel expenses (students and staff). This amount is calculated according to the following distance bands:

The project will cover a return ticket from home to host university for all grantees. The amount will be calculated considering the distance between the city of the Home University and UMA. Grants will be paid to the beneficiaries by the University of Malaga, according to real arrival and departure dates and UMA academic calendar.

#### IV. REQUIREMENTS AND APPLICATION PROCEDURE

##### a) General requirements- Eligibility

In order to participate in this procedure, the following requirements must be met at the end of the application submission period:

-All incoming grants at the University of Malaga during the validity period should adjust to the Inter-institutional Agreement previously signed with the partner institutions and published on [UMA web page](#) in the corresponding annex of places for a given academic year.

-To have an appropriate level of the language of instruction, B2 being the minimum level of Spanish or English. The University of Malaga will not require a certificate accrediting the language level of the applicants; however, each university will ensure that its candidates meet the language requirements to take advantage of the stay.

##### *Specific requisites for student eligibility:*

- To be enrolled for a recognized Bachelor, Master or Doctoral Degree at the same level of studies that is applying for, in one of University of Malaga 's partner universities at the time of application and during the mobility.
- To be nominated by the partner institution (Clause IV d)
- The same student may participate in mobility periods totalling up to 12 months maximum per each cycle of study independently of the number and type of mobility activities.
- Undergraduate students must be enrolled at least in the second year of higher education studies.
- To have prior written approval from UMA coordinator or Director (only Master's or PhD students).
- To submit a provisional Learning Agreement duly signed by all the parties (the candidate, the sending and the receiving institution). No nomination will be accepted if it is not supported by the corresponding document.

##### *Specific requisites for Staff mobility eligibility:*

- To submit a Mobility Agreement (STAFF) duly signed by all the parties (the candidate, the sending and the receiving institution). No nomination will be accepted if it is not supported by the corresponding document.
- To have a contractual relationship with their home institution at the time of application and during the mobility.





Mobilities and grants will be subject to the regulations and restrictions that may be issued by the authorities in relation to the health situation and the continuity of exchange programs and acceptance by the UMA Department/Faculty.

**b) Prior acceptance procedure for a place offered by UMA**

The nomination does not imply the granting of a grants, which will be subject to available funding and the pre-selection and definitive admission of the students/staff published (V. Resolution).

If a candidate receives a signed Mobility Agreement from the University of Malaga, this does not mean that he/she will be selected for the placement. A candidate with a signed Mobility Agreement may not be finally admitted for a stay at UMA for two main reasons:

- a) The candidate is not selected by his/her Home University to be part of the list of nominated persons.
- b) Although the candidate is nominated by his/her Home University, the place for which he/she is applying has received more than one applications. In this case, the coordinator of the home institution shall determine which of the applications received is the most suitable for the activity to be carried out.

**c) Selection procedure by the home university**

The participant must be nominated by the Home University and selected by the University of Malaga to process his/her admission to UMA.

The entire pre-selection process (call) at the home university will comply with the criteria of transparency and equal opportunities for applicants.

The specific pre-selection criteria will be developed and published on the web pages and social networks of each home universities for applicants based on this call and will be disseminated, as far as possible, in the local and regional media.

**Proposed Evaluation Criteria.**

Grants will be awarded on a competitive basis, based on the evaluation of applications by the home institution. The Home University will submit a list with pre-selected candidates according to the criteria established in the internal call of the Home University.

So that the Evaluation Committee of the Vice-Rectorate for Mobility and International Cooperation at UMA can assess the adequacy of the profile of the students or staff member nominated to UMA, in addition to the specific criteria established by each partner institutions in their own selection process, we strongly recommend the following scale criteria that comply with the criteria of transparency, inclusion and equal opportunities for applicants, established in the IIA previously signed and EU recommendations.

**d) Procedure for the nominations of participants from their partner university to the university of Malaga**

The partner universities may nominate the maximum of [students](#) or/and [staff members](#) included in their IIA. However, the nomination of the candidates does not imply the granting of a scholarship that will be subject to the fulfilment of the requirements, the supporting documents, funding available and pre-selection and final admission of the student/staff by UMA

The partner universities can establish, in addition to the list of nominees, a reserve list of students and staff member in the document "Letter of Nomination and Absence of conflict of interest". In the event that all places are not filled, UMA will proceed to evaluate the reserve list of each university.

To formalize the nomination, the partner universities must complete the on-line application form ([SMS/STAFF](#)) on UMA website and upload the required documents (table below) for candidates selected in the application form (see document "Guidelines and schedules" of any given year and project)

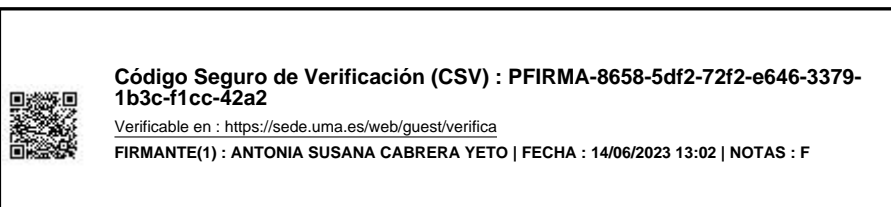

**e) Inclusion**

Candidates from disadvantaged backgrounds, with special needs or disabilities are encouraged to apply. They may receive additional funding according with the EU regulation in order to cover costs directly related to their participation in the mobility.

If the Home University nominates candidates with a disadvantaged profile, should send an email to [icm@uma.es](mailto:icm@uma.es) with information, and support documents and certificates that justifies the student's health problems (physical, mental, intellectual or sensory impairments and chronic disease which prevent participation in mobility) or disabilities (equal to or greater than 33%).

Additional funding to cover costs directly related to their participation in the mobility can be obtained, and is conditionally approved by the Spanish National Agency. The request for additional financial support should be made separately from the application form. Partner institutions should duly justify the disability through the selection process.

The selection process will evaluate the applicants and will prioritize candidates according to the established criteria and budgetary availability.

**f) "Zero grant"**

In the event that the number of applications is higher than the number of grant places assigned to each country, or if there are not places available for the mobility requested, participants who have not obtained a grant can apply for a "Zero Grant".

Participants with a "Zero Grant" will have the same rights and obligations as participants with a full grant but will not receive Erasmus+ funding (neither individual support nor travel support).

**V. RESOLUTION OF THE MOBILITY CALL**


Once the nomination period has closed, the Evaluation Commission of the International Relations Office at UMA will distribute the grants equitably, considering the score assigned to each student by the home university, the supporting documentation provided in the nomination and the funds available (Interinstitutional agreements) for each partner university.

The nominations and documents received from partner institutions will be submitted to the selection commission made up of:

UMA will distribute grants and it will publish a provisional list with selected and rejected candidates, indicating the causes of exclusion.

There will be a period of 5 natural days starting from the day after the publication of the provisional list to correct and improve the application. The appropriate allegations must be sent by email to [icm@uma.es](mailto:icm@uma.es).

Once the correction period ends, allegations are resolved and all requirements are fulfilled, UMA will confirm the acceptance of the nominated candidates, publishing on its official website a definitive list of participants selected (with full grant and "Zero Grant") and excluded candidates, as well as a list of the applicants who have not obtained a place due to having a grade lower than the last selected one, in order to create a waiting list for possible resignations.

Selection results will be published in <http://u.uma.es/dVU/> and will be announced to the beneficiaries and partner universities by e-mail.

The final acceptance will be subjected to the fulfillment of the administrative procedures.

Reserve candidates will be placed on a waiting list and called upon if a grant becomes available.

UMA will send to the selected participants an email to confirm the acceptance with instructions on how to proceed to organize their mobility at University of Malaga.

The final acceptance will be conditioned to the admission of the mobility period by University of Malaga according with the Guidelines and Schedule of a given year and project.

Candidates must comply with the requirements of both home and host university regarding all the requested documents and proofs of the stay.

In case of lack of applications, the Evaluation Committee reserves the right to re-distribute grants:

- Across Student and Staff categories and IN and OUT flows within the same country.
- Across different countries within the same region

In the event that, for the same country of origin, there are grants from previous calls (projects) not being awarded, the grants for the projects with the closest deadline will be awarded first. See Annex with places available and institutions every year.

## VI. ADMISSION FORMALITY PROCEDURE TO THE UNIVERSITY OF MALAGA FOR ELIGIBLE CANDIDATES

**At least 60 days before the start of their stay**, the selected candidates must contact the University of Malaga at [icm@uma.es](mailto:icm@uma.es) to start the admission process. where the following documentation must be provided:

i. **Before mobility**, participants should proceed as follows:

- To sign and send the Grant Agreement
- To sign the definitive Learning Agreement (SMS)/ Mobility Agreement (STAFF) with the respective home and host academic coordinators, at least 10 days prior to the start of the mobility.
- To apply for the visa in the country of origin. To make it easier to obtain, UMA will issue a letter of invitation to each participant.
- To send a copy of the flight ticket.
- To be in possession of adequate insurance throughout the mobility period according to Erasmus+ programme rules. The cost of the insurance will be covered by the participants themselves.







It is mandatory to adhere to one of the insurance policies subscribed by University of Malaga for travel and healthcare that have the coverage required in the Erasmus+ programme:

- travel insurance, including damage or loss of luggage;
- medical expenses, accidents, and serious illness (including permanent or temporary incapacity);
- death, including repatriation,
- third party liability

Students (no applicable for STAFF) should proceed as follows

- To take Online Language Training before starting their mobility.
- To enroll in Algoria platform, considering the minimum number of credits established for each level of studies:

Grade/Master: Minimum 18 credits

Doctorate: They will not have a minimum of enrolled credits but they must indicate in the learning agreement "Research stay".

The selected students will receive a link to the online application (Algoria) to upload the documents requested.

**Important:** all documents have to be typed. Handwritten documents would not be accepted.

**ii. During the mobility** participants should proceed as follows:

- To stay at UMA during the period provided for in the grant agreement (exceptionally and with prior justification, at least 3 months for student or seven days for staff (5 days will be of activity and two days of travel).

Exceptional circumstances will make possible a longer extension but should be duly justified and authorized by this Vice-Rector's Office. Otherwise, the candidate will have to return the entire grants.

- To carry out the mobility stay according to the proposal and dates committed established every year. In the event of force majeure, the mobility period must be modified by signing an addendum to the agreement.

- To attend classes or carry out the research work indicated in the Learning Agreement and sit the exams that are part of the syllabus of the subject they are studying at the UMA.

- To attend the activities organized at the University of Malaga indicated in the Mobility Agreement (only staff).

- To participate, if requested, in sharing their mobility experience.

- To carry out the mobility according to the study proposal (SMS) or Mobility Agreement and committed dates of the specific project. academic year.

- To Complete the Erasmus+ Participant Report on the Mobility Tool platform within five business days after receiving the link (the link will be sent by email 30 days before the end of the mobility). This requirement will be mandatory for SMS and STAFF to receive the remaining amount of the grants.

The institution may request partial or total reimbursement of the financial aid received from participants who do not complete and send the EU survey on due time.

To assume responsibility for performing the mobility during the period established in the corresponding annex (Project and Call).





iii. **After mobility** participants (SMS/STAFF) should proceed as follows:

-To present, at a maximum of 10 working days after the return of the stay a copy of boarding passes or the means of transport used, from the point of origin to destination.

*For students*

-To send the transcript of records and recognition at the sending institution in order to complete *table D after mobility* of the learning agreement (not applicable to PhD students). For doctoral studies, academic recognition will include the preparation of the thesis, excluding research activities that are not specifically part of a study program)

*For staff*

-To complete the Erasmus+ EU Survey within ten business days after receiving the link.

- Any other obligation inherent to the Erasmus+ Programme and the internal regulations of the sending and receiving institutions.

## VII. COMPATIBILITY

Grants under the Erasmus+ Partner Countries KA 171 program are not compatible with any other Erasmus+ grants granted for the same exchange mobility period.

## VIII. RIGHTS OF THE BENEFICIARY

- To perform the entire mobility period awarded in the framework of Erasmus+ KA 171.
- To receive the grant according to the rates and conditions set out in the Erasmus+ Programme guidelines.
- To benefit from tuition fee waiver as a student, notwithstanding other fees for the use of certain services or activities that might be applicable.
- To receive information and advice on the application procedure from the home university, as well as pre-departure and on-site guidance from the host university.
- To have the study or teaching period abroad recognized by their home university.

## IX. INFORMATION

All of the information regarding this Call will be available on the UMA website

Should any doubt arise over the interpretation of this Call, the Selection Committee will decide on the case and interpret it in the light of the guidelines of Erasmus+ Programme.

## X. DISSEMINATION

The partner institution (home universities) will announce this call through their own websites and launch their selection process (specific call) through their own web pages and social networks, and will also report the news about this call in local and regional media.





## XI. DATA PRIVACY

In compliance with article 11 of the Organic Law 5/2018, of 5 December, on the Protection of Personal Data and Guarantee of Digital Rights, which regulates the right to information in data collection, we inform that personal data will be processed by the University of Malaga in its capacity as data controller in order to carry out the administrative management and enrolment of students, teaching and research Staff and administration and services staff for mobility programmes with foreign universities or companies.

Those interested may exercise the following rights: access, rectification, opposition, abolition, limitation, portability and the right not to be subject to automated individual decisions, including profiling, as well as filling a complaint in front of the Data Protection Delegate of the University of Malaga or in front of the "Transparency and Data Protection Board (<https://www.ctpdandalucia.es/es>)".

## XII. REVOCATION OF AN AWARD

The selected candidates who do not finally participate in the Mobility Program, without having submitted the corresponding withdrawal in writing, except for reasons of force majeure justified and valued by the Commission, may be penalized without participation anymore in organized mobility calls by the Vice-Rectorate of Mobility and International Cooperation of the University of Malaga.

This University may revoke a place granted with a full or partial refund of the aid, when the conditions prescribed for admission to the award have not been fulfilled or irregularities or fraud in the award procedure have been detected

## XIII. JURISDICTION

This call will be subject to the specific norms in this publication and the rules currently in force.

## XIV. ACCEPTANCE OF THE RULES

The nomination by the partner universities and the nomination of the candidates represents the acceptance of requisites and bases of the selection process establishes in this Call.

## XV. FIRST ADDITIONAL PROVISION
